Dear Neighbor:

This week our team toured many important venues in District 2. We joined Congressman Lowenthal and Lt Governor Eleni Kounalakis as well as the Mayor Pro Tem Paolo Morales of Cypress for a personal tour by Kelly Vlahakis-Hanks of her [ECOS](#) Earth Friendly Products manufacturing plant in Cypress. This company represents a model for the future related to reducing our carbon footprint, elimination of waste on site, non toxic solutions for cleaning and washing, and employee relations that value workers, especially frontline essential workers. We learned so much and I brought back products to share with our County departments for consideration of a non toxic alternative. I look forward to partnering with ECOS as we create our D2 sustainability and climate action plans as they are light years ahead of all of us. Anyone wanting a tour, please let us know and we will schedule. Businesses and public agencies can learn a lot from their model of operations.

Also on our tours this week, we visited the Joint Forces Training Base in Los Alamitos where we learned about their plans for future improvements to the base, experienced the classes offered by the [STARBASE](#) Academy that serves 5th graders from various schools for 25 hours of STEM learning, toured the nationally recognized [Sunburst Youth Academy](#) for at-risk teenagers, the JFTB Aquatics Training Center where our USA Gold Medal Women's Water Polo team train, and the airfield and fire department on site. This community resource offers so much for our local community while simultaneously working as a critical training base.

We ended our week touring the [Harbor Patrol](#) in Newport Beach as well as the [Pacific Marine Mammal Center](#) where we participated in releasing an elephant seal that was helped after injury.

Our district offers so many amazing resources to constituents. I'm enjoying learning about and sharing with you.

Our monthly Mayors meeting was hosted by Seal Beach Mayor Joe Kalmick at [Crema Café](#). We enjoyed their outdoor patio, sharing ideas, and providing updates on projects we are partnering on together. I've requested that all the Mayors help us to better understand the cost of providing homeless services and each city was asked to send in their budget actual costs from last year and plans for this fiscal year. The State funds nearly all homeless services provided at the county level, so I want to ensure that our cities not in the Big 13 are receiving their fair share of those funds to assist to prevent homelessness.

Finally, this week marks the beginning of Hunger Action Month and Child Awareness Month as well as the start of the South Coast Plaza [Festival of Children Foundation](#). We hope you will join us in supporting the amazing organizations that seek to help food insecure families and keep kids and seniors fed.

Thank you for getting your vaccine. We are starting to hit 70% vaccination rates in nearly every city.

Statement from Supervisor Katrina Foley on Orange County Residents' Right to Hear from Public Health Officials

Santa Ana,—Orange County Supervisor Katrina Foley (2nd District) released the following statement in response to Chairman Do and Vice Chairman Chaffee's decision to prevent county health officials from participating in my daily COVID-19 updates.

"Last night, I learned that Chairman Do and Vice Chair Chaffee directed Orange County Health Care Agency staff to stop participating in my regular COVID-19 updates. The pandemic is not over, and the community deserves timely information about how to protect themselves and their loved ones. With Labor Day approaching, I was looking forward to hearing from our health officials about the current COVID trends in Orange County and how community members could stay safe this holiday weekend while still sharing time with family and friends."

"I find it concerning that some view transparency as an abuse of power. As COVID-19 cases surged in August, I began holding regular virtual COVID-19 updates to help fill the information void due to the county's lack of public engagement. Since December 2020, the county has not held a public COVID-19 briefing. In July, the county removed the COVID-19 item from our Board meeting agendas, which was the only opportunity available to publicly ask our health officials questions on behalf of Orange County residents. We have obligation to inform and educate the community about this ongoing public health crisis."

"These virtual briefings with county health officers and other experts have helped disseminate accurate health information, debunk myths, and answer questions from community members. Despite some of my colleagues' belief that the county has provided the information, it has not always been widely accessible or easily interpreted by the general public."

"Now is not the time for politics to get in the way of public health. I encourage my colleagues to reverse their directive and join me in sharing information for the benefit of the Orange County residents that we have the privilege to serve."

"I will never stop doing my best to inform the public about this public health crisis. Orange County residents deserve accurate information. That is how we will finally end this pandemic and get back to living our best lives."



TRANSPARENCY IN GOVERNANCE

On March 11, 2021, President Biden signed the \$1.9 trillion American Rescue Plan Act (ARPA). As part of ARPA, local governments received funding promote economic recovery from COVID-19. Orange County was allocated **\$616.8 million**. This funding offers an unprecedented opportunity for Orange County to address immediate recovery needs and long-term challenges.

According to the Department of Treasury ARPA funds can be used for the following spending categories:

- Support urgent COVID-19 response efforts to continue to decrease spread of the virus and bring the pandemic under control
- Replace lost revenue for eligible state, local, territorial, and Tribal governments to strengthen support for vital public services and help retain jobs
- Support immediate economic stabilization for households and businesses
Address systemic public health and economic challenges that have contributed to the inequal impact of the pandemic

Transparency and accountability are top priorities for my office and I'm thankful for the county's efforts to make this information accessible.

County of Orange Launches American Rescue Plan Act (ARPA) and Coronavirus Aid, Relief, and Economic Security (CARES) Act Website

Strategic Financial Planning Process Underway; General Public May Provide Input on Website

Santa Ana, Calif. (August 31, 2021) – Today, the County of Orange has launched the [ARPA and CARES Act Transparency website](#) for constituents.

The website includes expenditure information related to both Acts, an overview of the ARPA funding and the 2021 Performance Plan and links to the US Treasury ARPA website. The ARPA information will be updated periodically as new information becomes available. The website also includes the final reporting on the County's use of CARES Act funds.

In addition, the County kicked off its annual strategic financial planning process on August 16, 2021. The 2021 Strategic Financial Plan will be presented to the Board of Supervisors on December 14, 2021. This year's strategic financial planning process will include the County's plan and CEO recommendations on the use of the ARPA funds. The County of Orange received 50 percent of its \$617 million federal allocation on May 21, 2021 and will receive the remaining funds no earlier than 12 months from May 21, 2021. The County's Budget Office will hold a public workshop at 1:30 pm on Thursday, September 30, 2021 in the Board of Supervisors Hearing and Planning Commission Rooms to educate the public on the County's strategic financial planning and budget development processes and use of the ARPA funds. CALIFORNIA SMALL BUSINESS COVID-19 RELIEF GRANT PROGRAM



A round of new funding will open up September 9 through September 30 for California's Small Business COVID-19 Relief Grant Program. The program provides grants of **\$5,000 to \$25,000** to small businesses hurt by the pandemic. Businesses are eligible based on annual revenue as documented in their most recent tax return. Until September 8, the program is processing waitlisted applicants from previous rounds. Waitlisted applicants do not need to reapply.
