## SUPERVISOR'S MESSAGE

This week we worked on a diversity of issues on behalf of District 2 residents and businesses. Our team continues to work with Newport Beach residents, city council members and staff to address regulatory reforms for sober living homes that protect patients and improve the quality of care while taking care to address neighborhood impacts and overconcentration. I shared my work with our Behavioral Health Advisory Board and we will begin a countywide mapping project so as to limit overconcentration.

Each week I attend numerous Board Commission and Committee meetings. This week on the OC Transportation Authority and the OCTA Finance Committee we discussed our financial strategic plans, the savings from refinancing, our diversity and inclusion efforts for our bus system, our youth ride free passes for students to age 25, and efforts to support active transportation. We met with District 2 elected officials on Zoom to share the programs, priorities and planning underway to take our transportation system into the future.

I also participated in a town hall for Orange Coast College about the oil spill. It was wonderful to listen to the well-thought-out questions and to know that so many students care about protecting our environment. Speaking of OCC, I loved attending the Orange Coast College Student Union and Open House ribbon cutting today. What a wonderful example of our community pulling together to improve our education facilities for future generations.

## **Statement from Orange County Supervisor Katrina Foley on FBI Arrest of Huntington Beach Resident Related to January 6 Capitol Riots**

**ORANGE COUNTY, CA** – Orange County Supervisor Katrina Foley (2nd District) released the following statement in response to the news that the Federal Bureau of Investigation (FBI) arrested Huntington Beach resident Kim Michael Sorgente on suspicion of involvement in the riots that took place at the United States Capitol on January 6, 2021. Mr Sorgente is also an active anti-mask and anti-vaccine movement organizer in Orange County.

"Mr. Sorgente is a dangerous individual who has been a leader in the anti-mask and anti-vaccine movement since the beginning of the pandemic. Prior to joining the Board of Supervisors, when I was the Mayor of Costa Mesa, he protested at my home when our city issued a mask requirement to protect public health. Since joining the Board in March of this year, he has regularly attended our meetings to spread lies about COVID-19 and vaccines. Moreover, he regularly criticized me for following public safety guidelines and wearing a mask indoors. Mr. Sorgente's radical behavior escalated over time. He again joined others to protest at my home earlier this year and verbally harassed my family, interrupted my remarks at an event in Huntington Beach to remember the victims of the 9/11 tragedy, which required a police escort to my vehicle to safely leave the event, and most recently attempted to disrupt an event related to the oil spill in Laguna Beach. I encourage all of our elected representatives and community leaders to denounce this type of behavior that is dangerous for all of us. I hope Mr. Sorgente will face consequences for his involvement in the insurrection."

## OC OIL SPILL UPDATE

The following is an update on the Orange County Oil Spill, as of October 28, 2021:

- All harbors and public beaches in Orange County are open
- Approximately 524,422 pounds of oily sand and debris has been removed and 5,544 gallons of oil has been recovered
  - OC—160 lbs. collected
  - SD—1,600 lbs. collected
- No surface oil is present within Orange County waters.
- 457.11 total miles surveyed and cleaned by SCAT (Shoreline Cleanup Assessment Teams)
- Much of the shoreline is moving into the final phase(s) of clean-up
  - A long-term (as necessary) clean-up plan is being finalized
- Fisheries remain closed
  - Offshore seafood sampling should be completed this weekend
  - Testing on samples is expected to begin on Monday, November 1, 2021. Lab results will take 14 business days, including risk assessment and recommendation
- Vessel Decontamination is currently underway in Huntington, Newport and Long Beach Harbors
  - 59 cleaned, 75 scheduled and over 100 pending scheduling and initial observation
- Business Impact Recovery
  - Claims (866) 985-8366

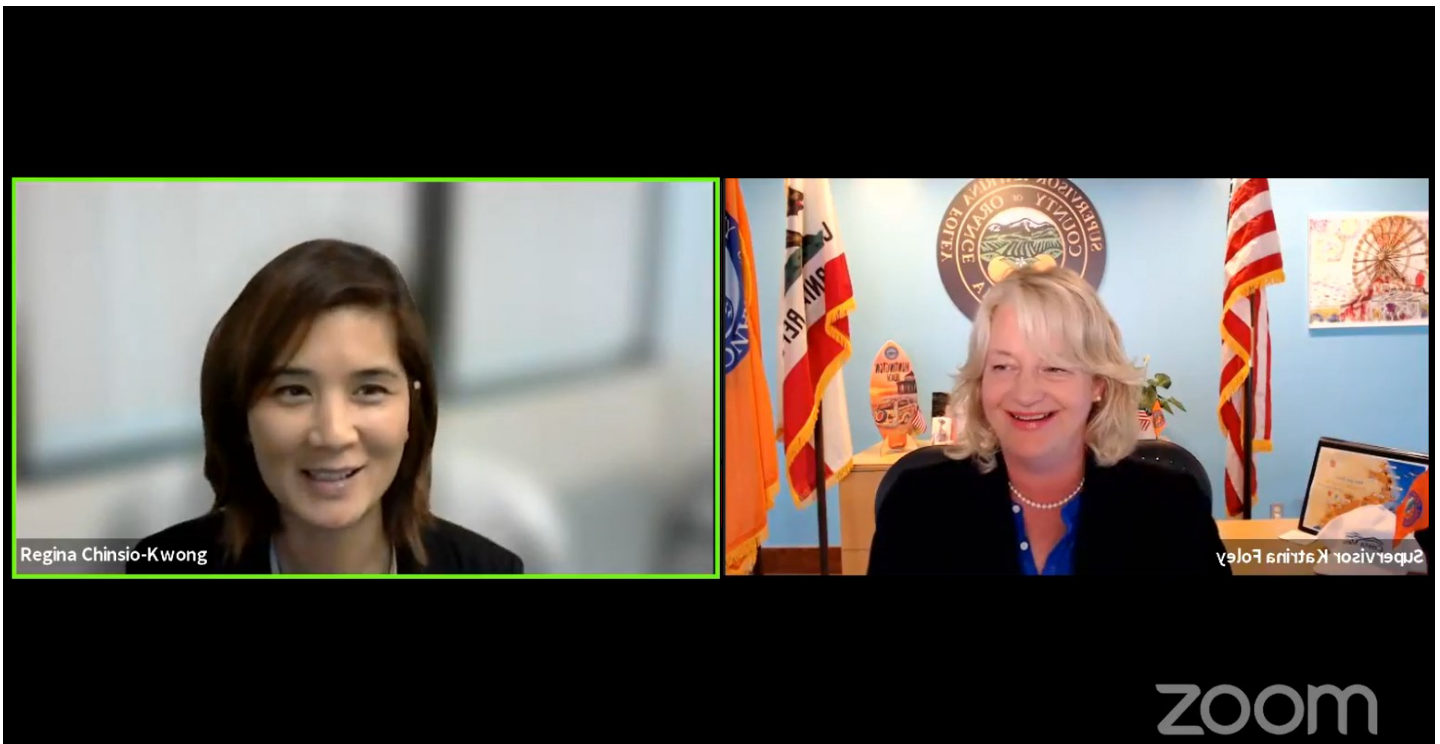
### COVID-19 Update:

Unfortunately, as of today there are 49 cases currently in the ICU (compared to 39 last Friday) and 3 deaths (compared to 5 last Friday). This pandemic is not over and our office will continue our efforts to vaccinate the community.

1. OC Health Care Agency awaits further direction on vaccine eligibility for children ages 5-11 from the FDA, CDC, and CA Department of Public Health.
2. If you received Pfizer or Moderna for your primary series, you are eligible for a booster dose at least 6 months after your second shot if you are:
  - A. 65 years or older
  - B. Age 18+ who live in long-term care settings, who have underlying medical conditions, who are at increased risk due to social inequity, or who work or live in high-risk settings
  - C. If you received Johnson & Johnson for your primary series, you are eligible for a booster dose at least 2 months after your 1st shot if you are 18 years or older

RE: Agenda Item No. 6: Formation of an Ad Hoc Residential Care Facilities Committee

Dear Mayor Avery and City Council Members:

I'm writing to support Agenda Item No. 6: Formation of an Ad Hoc Residential Care Facilities Committee. I appreciate the diligent work done by city staff. My county team and I look forward to future collaboration on this critical issue.

On August 25, 2021, a young man lost his life. Around 4:00 a.m., Henry Richard Lehr, 23, left his state licensed alcohol and drug treatment facility, Gratitude Lodge, and forced his way into a neighborhood home. He was shot and killed by the homeowner who was found to be acting in self-defense by the District Attorney. According to reporting from the *Orange County Register*, Henry Lehr's father believes his son was experiencing a "symptom of withdrawal, a psychotic episode." Two families and the surrounding community were devastated.

At a minimum, the community deserves accountability, transparency, and enforcement of existing state laws and regulations. I am working with Assemblywoman Cottie Petrie-Norris to formally request that the Department of Health Care Services (DHCS) investigate Gratitude Lodge and provide written assurances to my office and the community that this facility is in strict compliance with all regulations concerning state licensed alcohol and drug treatment facilities. If not, the facility should be closed.

Even before this tragic incident, the Santa Ana Heights neighborhood has been significantly impacted by two state licensed drug and alcohol treatment facilities (including Gratitude Lodge) and two unlicensed sober living homes. The negative social impacts resulting from the location of these licensed and unlicensed facilities have been evident for years. In fact, the close proximity of the facilities and their patients undermines the recovery from alcohol and drug addiction that residential settings are intended to promote.

As you know, I've worked diligently on regulatory reform for many years. The legal precedent set in *Yellowstone Women's First Step House, Inc., et al v. City of Costa Mesa*, SA CV 14-01852-JVS (JDEx) (C.D. Cal. Oct. 7, 2021) creates new opportunities to address real local

control rules and enforcements. I encourage you to consider possible local reforms like permitting, distancing, and quality of life measures at this time.

Thank you for your time and consideration of this important matter. Please do not hesitate to reach out to my office to discuss these issues further. I am committed to finding solutions that address the proliferation and over-concentration of unscrupulous sober living home operators throughout the Second District. I look forward to working together on this important issue.

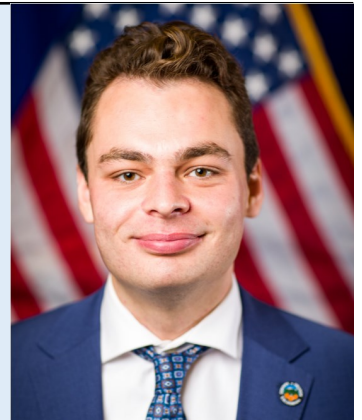

Yesterday, I attended the Orange County Juvenile Justice Coordinating Council's quarterly meeting with Supervisor Foley. She joined the rest of the Council in voting to approve the county's plan in response to SB 823, also known as the "Juvenile Justice Realignment: Office of Youth and Community Restoration." This legislation established a block grant program for the purpose of providing county-based custody, care, and supervision of youth who were eligible for commitment to the Division of Juvenile Justice prior to its closure. In December, the Board of Supervisors will consider this plan.

We look forward to continue working with stakeholders to ensure that Orange County maximizes public safety, while promoting opportunity for our most vulnerable youth in the juvenile justice.

## **Supervisor Katrina Foley Announces Parking Relief, Solution to Street Sweeping Issue in Rossmoor**

*Orange County, CA* – Orange County Supervisor Katrina Foley (2<sup>nd</sup> District) and Joe Mendoza, General Manager of the Rossmoor Community Services District, released the following statements in response to the unanimous support by the Orange County Board of Supervisors to address the issue of total street parking closures during street sweeping in the unincorporated community of Rossmoor.

"After taking office in March of 2021 I learned that Rossmoor residents are currently forced to park outside their neighborhoods when street sweeping occurs due to total street parking closures", **said Supervisor Foley**. "For many years community members asked that street sweeping occur on alternate days so they are not forced to park outside of their neighborhoods. I worked directly with the Rossmoor Community Services District and Orange County Public Works to finally find a solution. The Orange County Board of Supervisors recently approved funding to allow street sweepers to alternate streets. I will continue to partner with Rossmoor residents to address these important quality of life issues."

"For more than 30 years, residents have not had an alternative and were restricted from parking on all Rossmoor residential streets on street sweeping days from 8:30 a.m. to 4:30 p.m.", **said Joe Mendoza, Rossmoor General Manager of the Rossmoor Community Services District**. "Supervisor Foley heard our concerns and initiated this schedule change to improve the quality of life for Rossmoor residents. We are extremely appreciative of her leadership and assistance. The Rossmoor Community Services District Board of Directors would like to sincerely thank Supervisor Katrina Foley for representing Rossmoor residents by successfully leading the effort to change the street sweeping ordinance in Rossmoor to provide a schedule that is anticipated to provide significant parking relief to our approximately 10,500 residents and 3,500 homes. By changing the street sweeping schedule to the first and third Mondays for the odd numbered addresses side of the street, and the even-numbered side of the street on the second and fourth Mondays, residents and visitors are provided with parking alternatives to avoid a parking violation ticket."

### **SBA Offers Disaster Assistance to California Small Businesses Economically Impacted by the Pipeline Oil Spill**

#### **Virtual Business Recovery Center to Open Thursday, Oct. 28**

**SACRAMENTO, Calif.** – The U.S. Small Business Administration is offering low-interest federal disaster loans for working capital to small businesses economically impacted by the pipeline oil spill that began Oct. 2, 2021, SBA’s [Administrator Isabella Casillas Guzman](#) announced today. SBA acted under its own authority to declare a disaster in response to a request SBA received from Gov. Gavin Newsom’s designated representative, Mark S. Ghilarducci, director of the Governor’s Office of Emergency Services, on Oct. 22, 2021.

The disaster declaration makes SBA assistance available in Los Angeles, Orange, Riverside, San Bernardino and San Diego counties.

“SBA’s mission-driven team stands ready to help California small businesses impacted by the pipeline oil spill,” said Administrator Guzman. “We’re committed to providing federal disaster loans swiftly and efficiently, with a customer-centric approach to help businesses and communities recover and rebuild.”

In consideration of the public health concerns due to the Coronavirus pandemic, [beginning Thursday, Oct. 28](#), SBA will establish a Virtual Business Recovery Center to answer questions about SBA’s disaster loan program, explain the application process and help each individual complete their electronic loan application.

“Small nonfarm businesses, small agricultural cooperatives, small businesses engaged in aquaculture and most private nonprofit organizations of any size may qualify for Economic Injury Disaster Loans of up to \$2 million to help meet financial obligations and operating expenses which could have been met had the disaster not occurred,” said Director Tanya N. Garfield of SBA’s Disaster Field Operations Center-West.



“These loans may be used to pay fixed debts, payroll, accounts payable and other bills that can’t be paid because of the disaster’s impact. Disaster loans can provide vital economic assistance to small businesses to help overcome the temporary loss of revenue they are experiencing,” Garfield added.

Eligibility is based on the financial impact of the disaster only and not on any actual property damage. These loans have an interest rate of 2.855 percent for small businesses and 2 percent for private nonprofit organizations with terms up to 30 years and are restricted to small businesses without the financial ability to offset the adverse impact without hardship.

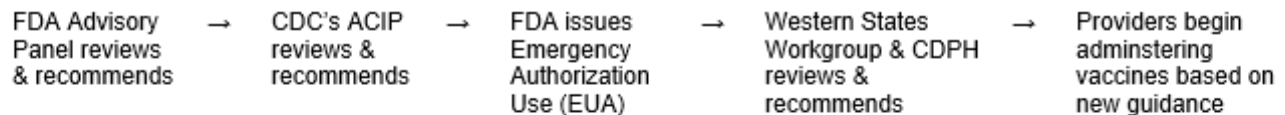
## OC Health Care Agency Monitors Status of Vaccine Eligibility for Children Ages 5-11, Issues Reminders on Halloween Safety

(**Santa Ana, CA**) – To prepare for the next phase of vaccination distribution, the OC Health Care Agency (HCA) continues to monitor activity by the U.S. Food and Drug Administration (FDA), the Centers for Disease Control and Prevention’s (CDC) Advisory Committee on Immunization Practices (ACIP) and the California Department of Public Health (CDPH) regarding COVID-19 vaccine eligibility for children ages 5-11.

Earlier this week, an advisory panel at the FDA convened a meeting to discuss information and data that may support the administration of the Comirnaty (Pfizer) COVID-19 vaccine for children ages 5-11. The CDC’s ACIP will be meeting November 2-3 to conduct the review.

“The HCA is required, along with other COVID-19 vaccine providers, to administer vaccines in accordance with all program requirements and recommendations,” says **Dr. Clayton Chau**, HCA Agency Director and County Health Officer. “Similar to the actions taken for the recent authorization of booster doses, we ask for the public’s patience as we await further direction on vaccine eligibility for children 5-11 from the FDA, CDC, Western States (California, Nevada, Oregon and Washington) Scientific Safety Review Workgroup and CDPH.”

The illustration below shows the process by which the COVID vaccines are authorized:



Vaccines continue to be widely available throughout Orange County for walk-in, same day and future appointments. Individuals who are not yet vaccinated against COVID-19, anyone eligible to receive a booster dose and those eligible for a third dose (immunocompromise conditions) are encouraged to visit a local pharmacy or healthcare provider, or go online to [Vaccines.gov](https://www.vaccines.gov) , [MyTurn.ca.gov](https://www.MyTurn.ca.gov) or [Othena.com](https://www.Othena.com) , to schedule a vaccination appointment. HCA vaccine clinics are continuing to deliver vaccines to the most vulnerable population and hard-to-reach communities in Orange County.

## Precautions for Safe Halloween

In anticipation of Halloween celebrations, the HCA reminds residents to take the following special precautions to reduce the spread of COVID-19:

- **Keep Your Distance:** Trick-or-treating can sometimes lead to crowds when walking or waiting for candy to be handed out. Keep a safe distance from others who are not part of your household.
- **Wear a Mask:** Face coverings are strongly recommended, even outdoors where there are crowds of people you do not know, and especially for children not currently eligible for the vaccine. If there is adequate spacing outdoors, masks are not necessary; however, unvaccinated or high risk individuals should use additional protection with a mask that snugly covers the mouth and nose in the event they are in crowded areas indoors or outdoors.
- **Play it Safe:** Instead of gathering indoors, when possible, consider outdoor Halloween activities such as a haunted outdoor play area, outdoor scavenger hunt, or outdoor Halloween themed dinner.
- **Giving Candy:** Distribute candy outside by setting up a station with hand sanitizer and individually wrapped candies or goodie bags for Trick-or-Treaters to help themselves, allowing for social distancing.

“Although we have been seeing a decline in our COVID-19 cases over the last several weeks, we have started to see slight increases in ICU admissions in our county as well as other counties in the state recently,” says **Dr. Regina Chinsio-Kwong**, Deputy County Health Officer. “This should serve an indicator that we still need to exercise safe precautions to protect our loved ones and ensure that we don’t enter another surge.”

Children are also encouraged to walk safely and not run to avoid slips and falls. Adults should drive safely and be especially alert for pedestrians who may be walking, riding their bikes or skateboarding during the prime trick-or-treating hours of 5:30-9:30 p.m.

All residents celebrating Halloween should wear reflective gear, walk with a group of family members and carry a flashlight to see and so others can see them. To protect one another from getting COVID-19, everyone who is eligible and not yet vaccinated should get vaccinated. **Over 90% of COVID-19 hospitalizations continue to be among people who are unvaccinated.**

## Status of COVID-19 Cases in Orange County

Between October 22 and October 28, the seven-day average COVID-19 case rate dropped from 6.7 to 6.4 per 100,000 people, with the average number of daily COVID-19 cases declining from 216 to 205. The positivity rate also decreased from 2.5 to 2.4 percent and hospitalizations from 205 to 195 per day. ICU admissions have slightly increased from 43 to 53 per day.

# Community Reminder: Safety Standards for the Holiday Decorations in Public Areas



## Permits Needed for Holiday Displays over Public Areas in Unincorporated Orange County



### ? WHAT: Permit Needs

With public safety as the top priority, residents in unincorporated areas of Orange County are reminded that they must obtain an "encroachment" permit if they plan to place holiday displays, including strings of lights, over public rights-of-way such as public streets and sidewalks.

Please note that electrical wiring, including extension cords, are not allowed across the surface of public sidewalks or roads and are not permitted under an encroachment permit.

#### What you will need for an encroachment permit:

1. **Encroachment Permit Application:** To be completed by the home owner or Home Owner Association (HOA) as the applicant (if HOA, an authorized officer of the HOA Board must sign the application on behalf of the Board.)
2. **Site Plan:** Submit a diagram showing the location of light strands, decorations and other elements being placed in/over County right-of-way area. List addresses of all properties proposed for the specific display.
3. **Letter of Authorization:** To be completed and notarized by the person who will be representing the HOA and signing for the actual permit. **Note:** This is not required on single permits for individual properties where the homeowner is both the applicant and is signing for the permit.
4. **Credit Card Authorization:** The combined permit fees are \$355 for individual properties or single street (\$325 *Time and Materials deposit plus \$30 issuance fee*) or \$1,030 for multiple streets within HOA (\$1,000 *Time and Materials deposit plus \$30 issuance fee*). An additional deposit of \$1,000 is required and is refundable upon satisfactory closure of the permit.
5. **Insurance Information:** Proof of adequate liability insurance required with encroachment permit applications.
6. **Contractor Guidelines:** Outlines requirements and limitations for placing holiday decorations in the County right-of-way area. It is important that participants follow these guidelines to maintain safety.

### ✓ WHY: Enhancing Safety

The permit establishes guidelines to ensure public safety and code compliance for homeowner associations (HOAs) and individuals interested in installing holiday displays over public roads, sidewalks, parkways and public light poles. The purpose of the required permit is to ensure that displays over public rights-of-way are safely positioned, provide adequate clearance for emergency and service vehicles, and are installed with proper electrical connections. Obtaining an encroachment permit will ensure decorations are displayed in a safe and secure manner for an environment that protects families, property, vehicles and service providers.

**A permit is not required for displays on private property.**

To help minimize permit fees and meet insurance requirements, two other options for obtaining permits may be of interest:
