# Newport Beach



- \$3.3 Million Cost to OC Parks
  - Activities:
    - 88% in City Limits
    - 12% in Tidelands (Back Bay)
- Sec 26600 Vague on Sheriff Obligation



# Huntington Beach



- \$3.6 Million Cost to OC Parks
- Activities:
  - 68% in City Limits
  - 2% in Unincorporated
  - 30% Federal (Seal Beach Naval Station)



# Dana Point



- Not under discussion today
- County Owned
- \$3.6 Million - No Cost to OC Parks
- Costs reimbursed thru Dana Point Harbor Special Fund

# Harbor Patrol Source of Funds

- \$6.9 Million **OC Parks**
- \$1.9 Million **Newport Tidelands Fund**

**TOTAL: \$8.8 Million**

- Status Quo
- Only Mandated Services (*Phase-out*)
- Revisit 1975 Resolution No. 75-720  
(*Transferring Harbor Patrol to Sheriff*)
- Legal Clarification of Sec. 26600
- Greater Involvement by Private Towers  
(*Most services already covered by boaters' insurance*)
- Performance Auditor Assignment



# \$6.9 Million OC Parks Funding Phase Out Options

- **OPTION A (3 YR Plan)**

2010-11: \$4.6m

2011-12: \$2.3m

2012-13: \$0

- **OPTION B (4 YR Plan)**

2010-11: \$5.175m

2011-12: \$3.45m

2012-13: \$1.725m

2013-14: \$0

- **OPTION C (5 YR Plan)**

2010-11: \$5.52m

2011-12: \$4.14m

2012-13: \$2.76m

2013-14: \$1.38m

2014-15: \$0
