WHEREAS, Supervisor Bill Campbell wishes to honor the outstanding accomplishments of Richard K. Wagner for his service to the residents of North Tustin; and

WHEREAS, the North Tustin Advisory Committee, also known as "NTAC," was established in 1990 by the Orange County Board of Supervisors; NTAC is a seven-member advisory committee that was created in place of the North Tustin Municipal Advisory Council to specifically advise the County and the Third District Supervisor on proposed land developments in the unincorporated area of North Tustin; and
