

Disaster Service Worker

California Government Code Section 3100 - 3102 All public employees are disaster service workers.

Orange County Emergency Services Ordinance No. 098-4


Defines disaster specific roles of the four County Directors of Emergency Services

- Addresses membership of Emergency Management Council (EMC)
- Designates OCSD as the Lead Agency

The mission of the Orange County Sheriff's Department's Emergency Management Bureau is to promote, facilitate, and support County of Orange and the OA efforts to prepare for, respond to and recover from disasters.

When Do We Activate the EOC?

Activation of the OA/EOC is required: Upon Request

- Two Cities Proclaim a Local Emergency, or County and City Proclaim a Local Emergency
- Request for Resources Outside the Operational Area
- Request for Governor's Proclamation/Presidential Declaration of Emergency


