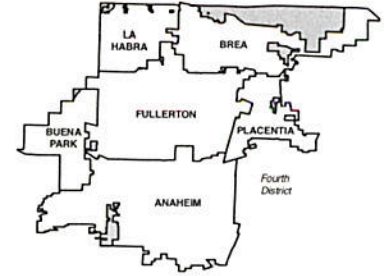

Your professional performance and humanitarian compassion for the Sanchez family is a model of conduct for all Police Officers and in keeping with the highest traditions of Law Enforcement.

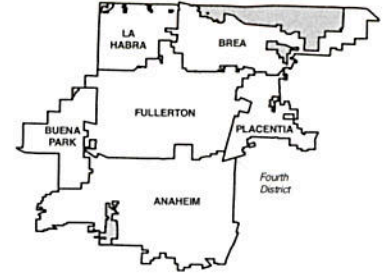
