*WHEREAS*, when Clancy dialed 9-1-1 for assistance, he was able to accurately provide his address, phone number, and what the emergency was despite the difficult circumstances. He was excellent at following directions and was able to provide the dispatcher everything he needed to get help to his sister; and


*WHEREAS*, Clancy frequently updated the dispatcher with his sister's current condition, while answering all of his questions; and
