WHEREAS, Colleene Preciado has given generously of herself during her outstanding thirty-four year public service career with the County of Orange and has attained the highest level of excellence, and it is appropriate at this time that she be extended special commendations; and

WHEREAS, Ms. Preciado began her County career as a Child Support Officer with the District Attorney's Office in June 1976; she was quickly promoted to Deputy Probation Officer and served in a number of assignments such as Adult Supervision, Juvenile Supervision and the Program Division; in August 1986, Ms. Preciado was promoted to the position of Supervising Probation Officer and, in 1989, was transferred to the Gang Unit; and

WHEREAS, Ms. Preciado has been selflessly committed to helping others throughout Orange County, serving as Co-Chair of the United Way Campaign in 2008 and Chair in 2009, working as a Standards and Training for Corrections certified trainer, a Member of the Orange County Gang Investigators Association and volunteer mentor for the Orange County Bar Foundation's nationally recognized juvenile diversion program; and
