

## History



- DNA Stakeholders Meetings
  - Eight Meetings: July 2 September 18, 2008
- Board Directive October 27, 2008
  - Created the Cooperating Department Head Structure
  - Recommendations:
    - Rename Sheriff's Crime Lab to OC Crime Lab
    - Hire DNA Laboratory Director
    - Proceed with high-volume crime DNA testing

# Cooperating Department Head Structure

- Members include Sheriff, District Attorney and CEO
- Supervise the Crime Lab Director
- Hired a DNA Lab Director
- Oversight of the administrative policies of the entire Crime Lab
- Began bi-weekly meetings on July 31, 2009
- Appointed Thomas Nasser as Acting Crime Lab Director on Jan. 11, 2010

#### OC Crime Lab & DNA Lab Director

- Hired DNA Lab Director Elizabeth Thompson in June 2009
- Renamed Sheriff's Forensic Science Services to OC Crime Lab in August 2009





# High Volume DNA Testing Progress


- Continued to expand testing and technology in the Crime Lab
  - implemented additional robotics
  - improved DNA analysis software
  - upgrades and improvements to the DNA report writing software




# High Volume DNA Testing Progress

- Implemented DNA Case Triage
  - Joint effort between the DA's office and the Crime Lab's DNA Supervisors
  - Trained OC police agencies from June August 2009 in DNA submission guidelines, case priority, and triage
  - Helped reduce the number of items that are submitted for property crimes.
- Analyzed more property crime cases and decreased DNA backlog due to the triage process and overtime funded by the 2008 NIJ Backlog Reduction Grant (\$508,212).

### Median Turn-Around Times





• OC Crime Lab still submits the largest number of DNA profiles and still has the largest number of DNA cold hits than any other California crime lab

- Recruitment to remain open until the needs of the Department are met.

## Summary

- Coop Dept Head Structure has improved communication and cooperation
- Accreditation status has been maintained
- Budget issues are affecting the Crime Lab like others
- Guidelines and practices to separate policy decision from management and scientific decisions are being monitored and discussed
- There is no interference by the Coop Dept Heads on scientific issues
- Recommendation The Coop Dept Head structure is working and should remain in place until we report back to the Board during the Budget
