NEWS ON AQMD'S VOTE TO BAN BEACH FIRES: DSBIA has taken a

public stand against the South California Air Quality Management District's proposal to ban beach fires in Orange and Los Angeles counties and to remove beach fire rings. We have urged our members and

friends to contact the AQMD, as well as local and state political officials to voice their opinions. We have received word that the AQMD is postponing it vote on beach fires from May 3rd to June 7th. **Don't let up, Keep the pressure on!**

"...the public hearing for Proposed Amended Rules (PAR) 445 – Wood-Burning Devices and PAR 444 - Open Burning remains scheduled for the May 3, 2013 Governing Board meeting, <u>except</u> for the provisions related to open burning at beaches which has been rescheduled for the June 7, 2013 Governing Board meeting.

Both meetings are scheduled to begin at 9:00 am and will be held at the SCAQMD offices in Diamond Bar.


