**NOTICE IS FURTHER GIVEN** that the air quality objective of Proposed Amended Rule 444 is to protect public health by reducing particulate emissions from wood smoke from beach burning activities. The key elements of the proposed amended rule are summarized below:

Adds a definition for beach burning activities.

 Prohibits beach burning activities after January 1, 2014 during high pollution days.

• Prohibits beach burning activities after June 1, 2014 at all times unless specified criteria are met.

Local jurisdictions to explore the use of low emission alternatives.

• Other amendments to clarify rule implementation and intent.
