Figure 1: Up-to-Date Immunizations at Kindergarten Enrollment, Private and Public Schools Within Each School District, 2012.



Figure 2: Conditional Enrollment at Kindergarten Enrollment, Private and Public Schools Within Each School District, 2012.



Figure 3: Personal Belief Exemption (PBE) at Kindergarten Enrollment, Private and Public Schools Within Each School District, 2012.


