PROJECT:	The project will increase Orange County's regional mobility by providing a north-south alternative to Interstate 5 and will connect the communities of San Clemente, San Juan Capistrano, Rancho Mission Viejo, Mission Viejo, Ladera Ranch and Las Flores.
	The first phase of the La Pata Extension project, the La Pata Gap Connector, will extend the existing La Pata Avenue just south of Vista Montana in the City San Juan Capistrano to Calle Saluda in the City of San Clemente, with four new travel lanes for more than two miles. One of subsequent phases, the La Pata Widening, will widen the existing La Pata Avenue with one additional travel lane and a bicycle lane in each direction between Ortega Highway and just south of Vista Montana for one and a half miles. Another phase, the Camino Del Rio Extension, will extend the existing Camino Del Rio roadway up to the newly extended La Pata Avenue for approximately a half-mile.
FUNDING:	The project is funded by state and local financing including OCTA's Renewed Measure M (M2), Ladera Ranch and The Ranch Community Facilities Districts, State Proposition 1B Funds, La Pata Road Fee Program, OC Waste and Recycling, OC Public Works Road Fund (State Gas Tax), the City of San Juan Capistrano and the City of San Clemente.
