September 2010	<ul style="list-style-type: none"> Initial Ad Hoc Committee meeting held. Ad Hoc committee report presented to the Board of Supervisors. Board of Supervisors authorizes CEO to issue RFPs for Data Support, Mapping and Analysis Consulting Services and Legal Services.
November 2010	<ul style="list-style-type: none"> Ad Hoc Committee meeting to be held.
December 2010	<ul style="list-style-type: none"> Ad Hoc Committee presents recommendations on committee structure to the Board. Board of Supervisors adopts committee structure and rules of procedure including members, voting and public access plan. Board/Committee determine meeting schedule in accordance with the Brown Act.
January 2011	<ul style="list-style-type: none"> Contract Award for data support mapping, and data tabulation and analysis consulting and legal services.
February/ March 2011	<ul style="list-style-type: none"> Target dates for Release of US Census Data – Population Data.

Structure for Supervisorial Redistricting

- **Membership:** Five Voting Members
 - One Executive Assistant & Alternate nominated by each Supervisor.
- **Meetings:** All meetings to be held in accordance with Brown Act.
- **Voting:** All Committee action shall require a majority vote of total membership.
- **Tasks:**
 1. The Committee will recommend to the Board of Supervisors adoption of a Decennial Redistricting Plan.
 2. Committee will adopt and prepare a Public Access Plan for public outreach and participation
