1. There will be no limitation by the County on the number of organizations in any commercial category.
2. The poll site must comply with all requirements of the Registrar of Voters, such as location, parking, signage and accessibility.
3. All poll workers must meet the eligibility requirements as defined by the Registrar of Voters and described in the Poll Worker Recruitment brochure.
4. No commercial arrangement may be entered into under which the logo of the County or any of its departments can be reproduced and distributed in a manner to enable impersonation of a County official or a safety employee. (ORDINANCE NO.\_95-3956\_Article VIII SECTION 2-5-122)
5. Any licensee of advertising authorized under this plan shall not allow an advertising display or use of the County's intellectual property to give the appearance or impression that any commercial product or service is endorsed or recommended by the County of Orange or any of its agencies, departments, officers or employees. (ORDINANCE NO.\_96-395\_Article VIII SECTION 2-5-130)
6. The Orange County Registrar of Voters reserves the right to reject an application with any sponsor at any time without notice.
7. The Orange County Registrar of Voters reserves the right to cancel the Corporate Pollsite Sponsorship program at any time.
8. Submission of poll site information must be made at least ninety (90) days prior to a scheduled election.
9. Poll Worker names and qualifications must be submitted at least forty-five (45) days prior to a scheduled election.

THE COUNTY WILL PROVIDE THE FOLLOWING FOR A CORPORATE POLLSITE SPONSOR:

1. Permission to allow limited use of the designation as a Corporate Pollsite Sponsor and related use of the County logo, subject to prior County approval.
2. Media and event recognition for Corporate Pollsite Sponsors.
3. Special website will be designed and presented by the Registrar of Voters highlighting Corporate Pollsite Sponsors and their community contributions.

**Poll Worker Eligibility Requirements**

- 18 years of age.
- Registered to vote
- Speak, read and write English
- Not in jail or on parole for felony conviction
- Willing to work from 6:30 a.m. to 9 p.m. on Election Day
