WHEREAS, on March 19, 2010, Taylor Carter, a 12-year-old resident of Dana Point, effectively and efficiently used the 9-1-1 emergency system when her sister was having symptoms of a seizure; and

WHEREAS, when Taylor dialed 9-1-1 for assistance she was able to accurately provide her address, phone number, and what the emergency was despite the difficult circumstances. She was excellent at following directions and was able to provide the dispatcher everything she needed to get help to her sister; and

WHEREAS, Taylor frequently updated the dispatcher with her sister's current condition, while answering all of her questions; and


WHEREAS, during such a stressful situation, Taylor remained calm, was polite to the dispatcher while never losing her poise. Thanks to Taylor's 9-1-1 phone call, and quick action, her sister received necessary emergency medical attention.
