Veterans who apply for housing assistance through the Orange County Housing Authority receive the highest preference and placement on the waiting list. Veterans who reside outside of OCHA's member cities are also placed ahead of other non-residents on the waiting list.



Veterans Affairs Supportive Housing Program (VASH) provides permanent housing subsidies and case management services to homeless veterans through a collaboration of HUD and the VA Department.

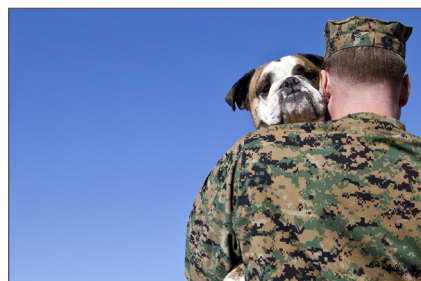

Veterans Campus program, also known as "The Drop Zone" works collaboratively with individual veterans attending college in Orange County. Using a behavioral health clinician who is also a veteran to identify and talk with veterans on campus improves the ability to screen for stressors and barriers that prevent veterans from being successful in achieving scholastic success. Veterans are screened and given the opportunity to enter the program and/or to be referred and linked to appropriate community and VA resources to assist with identified issues.

Veterans Court programs (Combat Veterans Court, Non-Criminal Domestic Violence Court) consist of services designed to identify, engage, assess and provide support for veterans involved with legal court issues in Orange County. Case management is provided as well as direct linkage to appropriate Orange County and VA veterans programs and resources such as employment, housing, health care, and substance use disorder treatment.

Older Adult Mental Health Recovery Services

Older Adult Mental Health Recovery Services is an in-home and clinic based mental health service for those 59 years and older. Program eligibility includes having a serious and persistent mental illness; participants may have a co-occurring substance abuse disorder and exhibit impairment in their ability to function in the community.



Program of Assertive Community Treatment (PACT)

PACT is for adults 59 years and older who are living with a chronic and persistent mental illness. OAS PACT provides assessment, linkage, individual and group therapy, extensive case management, advocacy, medication support and a variety of recovery services for older adults.

Senior Health Outreach Prevention Program (SHOPP)

SHOPP is an in-home service staffed by Public Health Nurses and Behavioral Health Clinicians.

The SHOPP Public Health Nurses (PHNs) offer home visitation to address the unmet health care needs of adults 45 years and older, though priority is given to frail, older adults. The PHNs provide public health field nursing assessment and services including health and tobacco education, short term case management, and linkage to resources.

The SHOPP Behavioral Health Clinicians provide initial outreach and engagement services, crisis intervention, assessment, and linkage to resources for older adults 60 years and older experiencing a functional impairment related to a mental health issue.

Substance Abuse Resource Team (START)

START is an in-home service for adults 60 years and older who have a serious mental illness and who are misusing substances such as alcohol, recreational drugs, and over the counter and prescription medications. START serves older adults unable to access traditional drug/alcohol abuse services.

Disabled Veterans' Property Tax Exemption

A veteran who is rated 100% disabled due to a service connected disability or the unmarried surviving spouse of such veteran may be eligible for an exemption on the assessed value of their home.

Service Members Civil Relief Act Declaration

If a service member is a legal resident of another state and is residing in this jurisdiction solely in compliance with military orders, any personal property purchased may be eligible for a tax exemption.

There is no fee for filing a Disabled Veterans' exemption claim or Service Members Civil Relief Act Declaration. Veterans may also apply to request copies of roll records or public assessment information.

Services include:

Compromise of Arrears Program (COAP) - a California program designed to help reduce child support debt owed to the government; a qualifying veteran will only be financially responsible for a portion of the child support balance.

Modification of Child Support - when financial circumstances change, veterans may request a Judicial Review and Adjustment to ensure child support obligation is appropriate.

Service Members Civil Relief Act - modification of an existing support order, reduced interest rate of 6% on arrears incurred before he/she entered active military appointment of legal counsel prior to establishing a default judgement.

Veterans and their dependents are able to record any U.S. Service Member's DD214 or official discharge paperwork free of charge. Free copies of any record, including birth and marriage certificates and property records, are also available to veterans using the record for official military use, such as applying for benefits.

Military personnel and/or their dependents must present valid government-issued photo identification and sign a statement under penalty of perjury that the requester is an authorized person and requesting records for military purposes.

Eligible veterans employed as a Deputy Sheriff I, on New Hire or Promotional Probation, are entitled to monthly benefits from the VA's GI Bill - Veteran's Education Benefits Program. OCSD facilitates the registration of the employee for the program, as well as documenting and forwarding a "Monthly Hours Worked" report to the VA.

The Public Defender staffs the Orange County Superior Court's Veterans Court. Veterans Court offers a therapeutic alternative and support services to US military service personnel who become involved with the criminal justice system, and who are in need of effective mental health treatment to address issues such as Post Traumatic Stress Disorder (PTSD), Traumatic Brain Injury (TBI) and other serious mental health problems. The court may assess Public Defender fees at the conclusion of the proceedings.

The CalFresh Program was established to improve the nutrition of people in low-income households by increasing their food-buying power so they can purchase nutritious food, such as fruits, vegetables, and other healthy foods, for the members of their household.

Medi-Cal is a health care program that pays for a variety of medical services for children and adults with limited income and resources. Some Medi-Cal covered services include doctor visits, hospitalization, nursing home care, dental, glasses, and prescriptions.

CalWORKs and Welfare-to-Work programs help the unemployed and underemployed achieve stable employment which promotes independence and self-sufficiency. The CalWORKs program provides cash benefits for the care of needy children when one or both parents are absent, disabled, deceased or unemployed/underemployed. The program requires clients to become employed as quickly as possible, and become self-supporting and not dependent on aid. Time on aid is limited to 48 months in a lifetime for adults, unless exempt.

GENERAL RELIEF

General Relief (GR) is a cash assistance program. It provides temporary cash aid to eligible indigent lawful adult residents who do not have custody of any minor children and do not qualify for Federal or State funded cash aid programs. General Relief benefits are considered to be a loan and must be repaid.

IN-HOME SUPPORTIVE SERVICES (IHSS)

IHSS authorizes necessary caregiving services to Medi-Cal eligible older adults and persons with disabilities to assist them in living safely at home.

An IHSS social worker makes an assessment of what your need for in home care is based on your medical condition, your living arrangement, and what assistance you may be getting from your family, friends or available community services. The needs assessment will determine which services are paid for, which may include house cleaning, shopping, cooking, laundry and personal care.

Supportive services include case management, financial planning, housing location, assistance in obtaining benefits and referral services, and possibly short-term financial support.

The Homeless Veteran Reintegration Program (HVRP) is a homeless veteran employment program which works to help veterans receive the training and other services they need to get good jobs. HVRP services include job counseling, resume preparation, occupational, classroom and on-the-job training, and job search and placement assistance.
